### REQUEST APPROVAL OF CONTRACT CHANGES WITH RELIANCE TELEPHONE FOR CORRECTIONAL FACILITY

Correctional Administrator Julie Savat provided the Board with information on new options that Reliance Telephone is starting in March. Taking advantage of their new options, via contract change, will result in an increase in revenue for the Correctional Facility and a reduction in their costs. The request is to sign a five-year contract.

On motion by Commissioner Weyland, seconded by Commissioner Haney, and unanimously carried, the Board approved the contract changes with Reliance Telephone for the Correctional Facility.

In response to an inquiry, Ms. Savat informed the Board that Correctional Facility staff will conduct a shakedown in the Phase 2 area of the Correctional Facility today. The last temporary wall will come down tomorrow, and the tunnel should be fully functional by next week. The new kitchen is open, and Trinity Food Service is working out great.

# REQUEST APPROVAL OF RESOLUTION 2020-12 FOR TRANSFER AND ASSIGNMENT OF ITS US DEPT. OF HUD PUBLIC HOUSING PROGRAM TO MOORHEAD PUBLIC HOUSING AGENCY

Dara A. Lee, HRA Director, and Dawn Bacon, Moorhead Public Housing Agency Executive Director, were present with a request. The request was for approval of a resolution agreeing to the transfer and assignment of its HUD Public Housing Program to the Moorhead Public Housing Agency effective on July 1, 2020. Moorhead Public Housing Agency would then be permitted to operate in Clay County and would

agree to complete any actions required by HUD. In 2017, Moorhead Public Housing Agency transferred its Housing Choice Voucher (Section 8) program to Clay County HRA. HUD has indicated it would be acceptable to transfer the on-going public housing financial assistance to the Moorhead Public Housing Agency to be used on its existing public housing developments. The housing units have significant capital improvement needs. It is anticipated that HRA could receive as much as \$450,000 over the next five years for this program.

On motion by Commissioner Weyland, seconded by Commissioner Campbell, and unanimously carried, the Board approved the following resolution:

## RESOLUTION 2020-13 Resolution to Assign HUD Public Housing program

WHEREAS, the Housing & Redevelopment Authority of Clay County (Clay County HRA) was created by the Clay County Commission on February 4, 1975;

WHEREAS, the Clay County HRA has contracted with the United States Department of Housing and Urban Development (HUD) since 1979 to operate public housing throughout Clay County;

WHEREAS, on December 31, 2018, after receiving the support of the Clay County Commission and the consent of HUD, the Clay County HRA disposed of all of its Public Housing property;

WHEREAS, the Clay County HRA does not own any public housing assets but continues to have a contract with HUD to receive Public Housing Program funding;

WHEREAS, the Moorhead Public Housing Agency also owns and operates Public Housing in Clay County, specifically within the City of Moorhead;

WHEREAS, the Moorhead Public Housing Agency has unmet capital and operation needs. NOW, THEREFORE BE IT RESOLVED, that the Clay County Board of Commissioners agree to the following:

- Assigns the right to receive Public Housing funds for Clay County to the Moorhead Public Housing Agency:
- 2. Permits the Moorhead Pubic Housing Agency to continue to operate in Clay County, specifically within the City of Moorhead; and
- 3. Agrees to complete any other required actions.

# RE-APPOINTMENT OF CECIL JOHNSON TO HIS THIRD FIVE-YEAR TERM TO HOUSING REDEVELOPMENT AUTHORITY (HRA) BOARD

On motion by Commissioner Campbell, seconded by Commissioner Mongeau, and unanimously carried, the Board approved the recommendation for Cecil Johnson to be re-appointed to the HRA Board for his third and final 5-year term.

## REQUEST APPROVAL OF ENVIRONMENTAL MONITORING EASEMENT ON CLAY COUNTY PARCELS

Eric Dodds and Jessica Warren, AE2S, and Chris McShane, Onstad Twichell Law Firm, were present with the request. Mr. Dodds handed out a set of maps with the area that the U.S. Army Corps of Engineers requested for their study and parcels that are owned by Clay County, Moorhead, and other public entities. Five of the parcels were purchased by Clay County through flood buy-outs. The Lands Committee recommended that payment for the Environmental Monitoring Easement be rejected.

On motion by Commissioner Weyland, seconded by Commissioner Haney, and unanimously carried, the Board approved an Environmental Monitoring Easement for five properties under Clay County ownership.

## AGENDA ADDITION: UPDATE ON INFORMATION REQUEST FROM BUFFALO-RED RIVER WATERSHED DISTRICT

Commissioner Campbell asked that he and Commissioner Mongeau be approved to review the data that that has been requested from the Buffalo-Red River Watershed District (BRRWD), to make additional data requests as needed, and to inquire with legal counsel as necessary.

On motion by Commissioner Weyland, seconded by Commissioner Haney, and unanimously carried, the Board approved Commissioners Campbell and Mongeau to review and oversee the data from BRRWD.

#### APPROVAL OF ANNUAL TOWNSHIP MAINTENANCE CONTRACT NUMBERS FOR 2020-2021

County Engineer David Overbo informed the Board that the township maintenance costs for 2019 have been calculated and divided by the miles of full-time maintenance to formulate the proposed 2020-2021 Township Maintenance Contract. The numbers were reviewed and approved by the Highway Tracking Committee on February 18 and shared publicly with the township officers for their input on February 20. For 2019, there was slightly less summer maintenance but significantly more winter maintenance hence the increase in the rate. Using a rolling five-year average, the proposed 2020-2021 contract is at \$775/mile, which is an increase of \$19/mile from the previous contract.

On motion by Commissioner Campbell, seconded by Commissioner Mongeau, and unanimously carried, the Board approved the annual Township Maintenance Contract for 2020-2021 with a rate of \$775/mile.

## ADOPTION OF RESOLUTION 2020-13 TO REIMBURSE CITIES FOR WORK COMPLETED ON CITY STREETS

Mr. Overbo recommended adoption of a resolution that he brings to the Board annually to provide funds to the non-state aid cities for work done on their streets; and funds to the City of Moorhead for city expenditures on the county roads that are within the city.

On motion by Commissioner Mongeau, seconded by Commissioner Campbell, and unanimously carried, the Board approved the following resolution:

## **RESOLUTION 2020-13**

IT IS HEREBY RESOLVED, by the Clay County Board of Commissioners that the Clay County Auditor-Treasurer shall reimburse the municipality of the City of Moorhead, a city of the second class in the State of Minnesota, for all monies expended by that government body for the establishing, locating, constructing, improving and maintaining of any County Highway or County State Aid Highway including those within the corporate limits of the City of Moorhead, Clay County, Minnesota. However, the monies expended directly by Clay County for the establishing, location, construction or improvement or maintenance of any County Highway or County State Aid Highway within the corporate limits of the City of Moorhead during the year 2019 shall be deducted prior to the reimbursement of any monies to the City of Moorhead as set forth above.

FURTHER, IT IS HEREBY RESOLVED that the City of Moorhead shall certify to the County Highway Engineer the location and the purpose for which said monies were expended and that the said monies were expended during the 2019 annual year. Monies shall not exceed \$373,697.83 and unexpended monies shall be encumbered.

### PRESENTATION ON REGION 4 REGIONAL TRANSPORTATION COORDINATING COUNCIL

Heather Molesworth, Family and Community Services Director for West Central MN Communities Action, provided a brief update on Region 4 Regional Transportation Coordinating Council. She handed out copies of the new regional directory for transportation providers in the nine Counties in Region 4. They are going into year three of their implementation on July 1. They found out in January 2020 that if they are to continue working on this project in Region 4, they will need a 10% match for their current \$268,000 grant through donations, etc. Ms. Molesworth met with all the public transportation providers yesterday about better utilizing the buses for 24/7 transportation options. She noted the Volunteer Driver piece of the program is in legislation this year. They are looking at insurance and tax liabilities and clearly defining Volunteer Drivers.
