



**Youth Camp** – For the purpose of such sections, a youth camp is defined as a parcel or parcels of land with permanent buildings, tents, or other structures together with appurtenances thereon, established or maintained as living quarters where both food and beverage service and lodging or the facilities therefore are provided for ten or more people, operated continuously for a period of five days or more each year for educational, recreational or vacation purposes, and the use of the camp is offered to minors free of charge or for payment of a fee.

**Public Swimming Pools** – Any pool other than a private residential pool, that is (1) open to the public generally, whether for a fee or free of charge; (2) open exclusively to members of an organization and their guests; (3) open to residents of a multiunit apartment building, apartment complex, residential real estate development, or other multifamily residential area; (4) open to patrons of a hotel or lodging or other resort, or other accommodation facility; or (5) operated by a person in a park, school, licensed child care facility, group home, motel, camp, resort, club, condominium, manufactured home park, or political subdivision with the exception of swimming pools at family day care homes licensed under section 245A.14, subdivision 11, paragraph (a).

**Spa Pool** - A hot water pool intended for seated recreational use with a water agitation system in addition to the recirculation system. Spa pool is synonymous with the term "whirlpool".

**Individual Water** - a private water supply other than a community public water supply.

**Individual Sewer** - a private sewage treatment system which uses subsurface treatment and disposal.

**Late Penalty** – additional charge added to the license fee when a person operates a business without first having made application and fee payment for the current year license.
