### Important Information Regarding Assessment and Classification of Property

Notice is hereby given that the following is a schedule of the 2022 Boards of Appeal and Equalization and Open Book meetings. The purpose of these meetings is to provide a fair and objective forum for property owners to appeal their valuation and/or classification.

If you believe the value or classification of your property is incorrect, please contact your assessor's office to discuss your concerns. If you are still not satisfied with the valuation or classification after that discussion, you may appear before the local board of appeal and equalization. You must have documentation to support your appeal. The board shall review the value, classification, or both if necessary, and shall determine if a change is warranted. An appearance before your local board of appeal and equalization is required by law before an appeal can be taken to the County Board of Appeal and Equalization. You may appear before the Boards of Appeal and Equalization or the Open Book format in person, through a letter or through a representative authorized by you.
